There are 5,710 children in state care who will be starting school soon; and depending on the child's location, will be in person, remote or a hybrid of the two!

Use this handout as a guide to ensure each child in state care is ready to learn!

Has the child changed placements in 2020?

DCYF Social workers should complete the School Notificaton form on the reverse to notify the new school of the change.



This also includes pre-K students as well!

Are the child's immunizations up to date?

School immunization rules changed Aug 1st:

- Immunization records must be medically verified;
- Tdap vaccine required for 7th grade
- Definition of "Conditional status" has been clarified



Does the child have or need special accommodations (504 or IEP)?

Treehouse's Education Advocates are tremendous resources in ensuring that kids educational needs are being met while in care. Contact edadvocacy@treehouseforkids.org with questions or for support.

Due to COVID-19, many districts are offering a choice between in-person attendance, remote learning, or a combination of the two.

DCYF is allowing caregivers flexibility in choosing the school option that best fits their family needs and centers around the student's best interest. If there's disagreement, first discuss with the other parties or bring to court as needed.

Has a BEST INTEREST determination been made regarding any school change?



RCW 28A.225.350

Students in foster care have a right to remain in their school of origin, even when placed outside the district. If **school of origin** is NOT in their best interest, the student is entitled to immediate enrollment in the new school. Priority should be to keep students connected to the school they've been attending.

Pandemic Food Assistance

Each child who was enrolled in K-12 and in foster care is eligible for up to \$399 in emergency COVID food assistance.



Applications due Sept 11 by 5 PM!

Students in foster care are categorically eligible for free school meals.

Does the child have access to technology for remote learning?



Check with the local school district regarding technology resources for students, including laptops and internet access. <u>Treehouse</u> might also be able to assist as well.



Additionally, <u>many internet providers</u> provide reduced fees if the child is already on public assistance, including food assistance as described above.
