

Data Collection

In early November Dr. Mikala Meize-Bowers, FTC Senior Research Associate, sent a copy of the WA FTC Performance Reporting Form (attached) to all FTC Coordinators, and respectfully requested the form be completed (as best they can) and returned to AOC twice a year (by Jan. 10 and July 10). This request was made for the following reasons:

- As a grant recipient, we are required to provide reports semi-annually to OJJDP.
- There is no statewide repository of this information, and the FTC Team at AOC is reliant on you sharing this information with us to know how to best support each team.
- Many of you asked what data you should be collecting, so you can review and begin continuous quality improvement (FTC Best Practice 8). In response, Mikala modified the extensive OJJDP Performance Measures to a more basic form, as a starting point, for you to assess who you are serving and their timelines through the program.
