# **Change Management**

CQI or Continuous Quality Improvement is a process of implementing small changes to improve the outcomes of your court over time.

The State FTC team (Julie, Mikala, Gia, and Meghan) looked at the state level performance measures data and noticed that families from Black, Indigenous, Biracial, and Hispanic racial identities are under-represented in family treatment courts, despite higher representation in dependency cases over all. We have started to implement some small but impactful changes which we will track to determine if they were successful. One of these was to give an example of a racial equity change that courts could implement easily and quickly. You can read though that example on our change management web page.


# **Technical Assistance**

## **Data Collection**





Data presentations are only as good as the data they are built from. In this case, we are looking at the Family Treatment Court referrals between July 2021 and December 2021 in Washington by race; something to pay attention to is the percentage of referrals that have no race reported. Nearly a quarter of referrals did not have their race marked in the data report. Because of this, we are unable to know the true distribution of race categories across our referrals. One thing we could work toward is making sure the referrals made to Family Treatment Courts are more clearly tracked. This will help local sites better understand the families referred and the families served. Consider using the change management tool to work toward accurately tracking who is referred to your program

#### FTC Codes:

In January 2022 new codes were introduced for Family Treatment Courts. The codes will allow local sites to review data, as it relates to child welfare outcomes (timeliness, disproportionality, etc.) and compare those to the traditional dependency track. The state team respectfully requests FTCs start using the new court codes for any participants that were active as of January 2022 or later. Thirteen of the nineteen counties have begun using the codes and are in varying stages of backdating successfully. Reviewing the National Evaluation of Family
Treatment Court (NEFTC) self-assessment results with
FTC teams lead to some great ideas about how to
meet Best Practices! There was a lot of information
shared in those meetings, and not everything can be

Key Components and brainstorm new ideas, we have

#### FTC Rural Access Roundtable:

On June 29th the FTC Grant team hosted a Rural Access RoundTable! We presented some research on virtual services, discussed some of the barriers FTCs face in rural counties, and how courts are working to overcome them. #### **Housing Committee MOU:**

The Housing Subcommittee has authored a Memorandum of Understanding (MOU) for DCYF and "Housers" (public housing authorities and other housing organizations). The Steering Committee voted on June 17th, in favor of distributing the MOU and cover memo in the name of the FTC Steering Committee to seek support from public housing authorities, nonprofit housers and legislators. The purpose is to establish a collaborative venture between the states housers and DCYF to provide housing vouchers and supportive services for DCYF clients' use when housing is necessary and would work to prevent the need for foster care, facilitate reasonable imminent reunification, or avoid homelessness for youth 18-25 who are aging out of foster care or JRA.

#### **New FTC Role Meetings:**

We recently began facilitating two new meetings with FTC team members! One is for FTC social workers, and they had their first meeting on June 28th. The second is for FTC peers and advocates, and they have had two meetings so far.
