## FWCC Meeting Notes 2/13/2023

#### Family Well-Being Community Collaborative

Mission: Collaborate to keep families safely together and supported in their communities and to radically reduce inequities within the child welfare court system.

#### Welcome and Land Acknowledgement

#### **FWCC Progress Update**

- Laura Vogel gave an update on what has been happening in the FWCC workgroups regarding the Crosswalks,
   iDecide, and Training.
  - Crosswalks
    - The FWCC workgroups have primarily completed the crosswalks, with the exception of the Ex Parte Removal Workgroup which has one meeting remaining to complete their crosswalk.

#### o iDecide

- The FWCC workgroups have been meeting on iDecide.
  - The Removal & Placement Decisions Workgroup has completed the first round of feedback for iDecide. The group is now working on making revisions to the tool based on this feedback. Kelly will help facilitate these conversations. Asked people who want to be part of the revisions they should make sure to attend the next few workgroup meetings.
  - The Harm of Removal Guidance Subgroup will be scheduling a meeting soon to continue discussion around creating resources and tools for understanding harm of removal.
  - The Family Time Decisions Workgroup has completed their crosswalk and is working with Laura to build the Family Time Decisions branch in iDecide. The workgroup will then be provided opportunities to supply feedback for revision consideration.
  - The Emergency Removal Decisions Workgroup is nearing completion of their crosswalk and will then start working with Laura to build the branch in iDecide.

- Paul Seabaugh reported that there has been a change to Monique Mitchell's participation at the CJC. Monique will be a keynote speaker for the CJC, along with doing a workshop on Relational Homes and the C.A.R.E. Checklist.
- Please contact Laura for a code to register for the CJC sessions at no cost if you are interested; she will
  provide you with what information you need.
- Participants were invited to share what their agencies are doing to prepare for HB 1227 implementation.
  - O DCYF Is doing a lot of training and informing.
    - For supervisors, they provided a basic training regarding *In re: K.W.* and HB 1227 and are currently answering questions from that;
      - Providing a weekly update; and
      - Offering regularly-scheduled office hours for supervisors to drop in and ask questions.
    - Regional staff trainings are being planned, along with office hours. Also working with The Alliance to develop simulation training.
  - WACAP Already adapted the core training for volunteers, including:
    - The concept that we need to stop waiting for parents to finish services before the kids can return home;
    - What role volunteers can play in helping with family search piece; and
    - Other ways for family to support and get engaged.

#### **HB 1227 Court Readiness Toolkit**

- Court Tools
  - Jennifer Nguyen reported that the HB 1227 Court Readiness Toolkit is out now and provided a demonstration of it. The Toolkit can be accessed on the <u>FYJP website</u> under "What's New at FYJP", or by clicking here: <u>HB 1227 Court Readiness Toolkit</u> This is the final assessment tool, which was created out of the FWCC workgroups, but we can still go back and make changes as we need to. The Toolkit includes the following three steps:
    - Step 1: Access Capacity
      - <u>HB 1227 Court Readiness Assessment</u> (assess current capacity to implement the major components of HB 1227 and identify areas in need of improvement)

- Step 2: Follow Roadmap
  - <u>HB 1227 Court Readiness Roadmap</u> (for use by cross-system teams to map their local shelter care process and provides tools, resources, and suggestions for how courts can capitalize on existing opportunities to improve process in each respective area)
  - <u>Implementation Retreat Storyboard Template</u> (developed to assist court communities in planning and facilitating local cross-system retreats to prepare for the implementation of HB 1227)
- Step 3: Analyze & Visualize Data
  - This is the next section we will work on. It will be designed in a way that courts can look at local level data, see if their processes are working, and see what they need to do.
- FJCIP Court Readiness and Implementation Pilot
  - o FJCIP Courts will be hosting HB 1227 Retreats for their stakeholders.
    - Sally Mednansky, Pierce County FJCIP Coordinator, shared what her court is planning to do in preparation for HB 1227, which includes:
      - Judicial officers that rotate to juvenile court will get an overview so they have a handle on what to do (30-minute training to get them oriented)
      - In March, Laura will provide a stakeholder training on HB 1227. Expect that attendees will
        take information back to their larger groups to consider what their roles are in the changes
        needed.
      - Following that, FJCIP will bring everyone back together for an HB 1227 Retreat
    - This will be a multi-step process. We hope with this time set aside, it will help courts build their capacity for the upcoming changes.
  - There are currently 10 FJCIP Courts in Washington and the program is in the process of expanding to 16.
     The program is providing funding for FJCIP HB 1227 implementation retreats and will follow up to see which changes and adjustments that courts make are successful and how they impact case outcomes. Another goal of this work is to share what we learn with the rest of the system.
  - If there are non-FJCIP counties interested in using the Court Readiness Toolkit to prepare for HB 1227, the
     FJCIP Team would be happy to help them, as well. The Meaningful Shelter Care Workgroup is also figuring out how to contribute helpful resources and assistance to courts.

#### Implementation and Outcome Evaluation Conversation

- Dr. Arina Gertseva is working with the FJCIP Team and will be forming an interdisciplinary FWCC Data
   Workgroup to monitor implementation and assess the impact of the Keeping Families Together court work.
- Dr. Gertseva reviewed the attached draft document, HB 1227 Implementation Considerations: The Practical, Robust Implementation and Sustainability Model (PRISM).
  - o HB 1227 Implementation Considerations
    - Real world implementation is difficult and impacted by many factors.
    - The evaluation will be guided by the PRISM approach, focused on three phases of the work:
      - adoption
      - implementation
      - maintenance
  - Key questions that will inform the evaluation
    - At every stage, we recognize the need to involve families to help us understand what families need and how the changes impact them.
      - Client Characteristics: important to understand the families and communities, and the local context, language and culture.
    - Has the effort received the input of key leaders, managers and staff? Do we have systems for data gathering?
    - How do professionals at different levels view success? What needs to be done to make the effort successful?

- How and who will gather performance data?
- External environment: implementation science is concerned about real life, so we want to figure out what factors can support or hinder the implementation of the new law in the community.
- Implementation and Sustainability Infrastructure: How much cross-system coordination is needed and how can we ensure equity, transparency, and support? How will we sustain the cooperation and learning – sharing successes and challenges through communities of practice?
- Reach and effectiveness: Is the intervention reaching the intended population? Who is benefitting?
- Adoption: How many courts have changed their practice? What does it take for this change to be integrated into a court and community process?

#### Discussion

- Attendees found this helpful as a way to understand how to assess the effectiveness and adoption of a new approach.
- Another question to consider What baseline data do we already have that we can use to assess impact by comparing pre-implementation and post-implementation?
- Excitement was expressed about the potential for this work and the knowledge and experience of the workgroup members. Alicia Summers, from the national Capacity Building Center for Courts, will be participating.
- Appreciation was expressed for all of the work that has been put into the design of the project, creation
  of tools and training resources and the evaluation. This is the first time such a thoughtful and
  comprehensive approach has supported the roll-out of an important change in the law.



### **HB1227 Implementation Considerations**

# The Practical, Robust Implementation and Sustainability Model (PRISM)

The PRISM helps to identify factors that may influence successful implementation and evaluation of HB1227. This framework considers all stages of implementation (planning and design, implementation operations, monitoring and outcome evaluation) and incorporates the perspectives of both the families and the stakeholders at different levels of influence (e.g., top leadership, mid-level managers, and frontline staff) to help understand what factors within and external to the courts need to be considered and addressed for successful implementation of HB1227.

<sup>&</sup>lt;sup>2</sup> It is critical to include the family perspective during all stages of planning and implementation. Key family--related features of implementation that should be considered include family- centeredness, providing choices, addressing barriers, striving for seamless transition between program elements, addressing service and access, and collecting family feedback.
